

SiriusXM Ultimate Backyard BBQ Package Sweepstakes for Automotive Dealerships

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A purchase will not increase your chances of winning. Void where prohibited. U.S. law governs. Open only to Dealerships in the Territory (defined below)

SPONSOR: Sirius XM Radio, Inc.

ENTRY PERIOD. The SiriusXM Ultimate Backyard BBQ Package Sweepstakes for Automotive Dealerships (the "Sweepstakes") begins at 12:01 a.m. Eastern Time ("ET") on July 6, 2020 and ends at 6:00 p.m. ET on August 21, 2020 (the "Entry Period"). Any entries received after the Entry Period will not be considered.

HOW TO ENTER. An owner or authorized employee of an eligible dealership in the Territory (a "Dealership") may enter the Sweepstakes on behalf of the Dealership by enrolling the Dealership in the SiriusXM® Service Lane Program and/or the Pre-Owned Program (each a "Program" or together the "Programs") and being "successfully activated" in the Program(s). Enter by going to www.siriusxmdealerprograms.com/BBQ2020 or www.siriusxmdealertrial.com/BBQ2020, following the instructions and enrolling in the Program. A properly completed and received enrollment in a Program shall be considered an "Entry."

"Successfully activated" means a Dealership enrolled and was accepted into the Program(s), and the Dealership received an activation acknowledgement from Sponsor no later than the end of the Entry Period. Proof of fax enrollment submission will not be deemed to be proof of receipt. Only two (2) entries per Dealership, one for each Program; the first enrollment to be submitted and cause the Dealership to be Successfully Activated in the Programs will be deemed the only valid entries.

Dealerships that are currently active and participating in the Programs will automatically be entered into the Sweepstakes with one Entry per Program in which they are currently active and participating. If a Dealership is chosen as the potential winner, it can choose to decline the prize.

Who Is the Entrant? The "Entrant" is deemed the Dealership. A winner can only be a Dealership. Sponsor will notify the Owner, Principal, or General Manager of the chosen Dealership of its status as potential winner. If the individual who enrolled the Dealership was not authorized to do so, or if the Owner, Principal or General Manager chooses to decline the Prize, the Prize will be forfeited, and Sponsor will choose a new potential winner from the remaining eligible Entries. The Dealership may, in its discretion, determine who within the Dealership may receive one or all elements of the Grand Prize, but regardless of such designation, will be responsible for paying any taxes on the full Grand Prize.

CONDITIONS OF ENTRY / ELIGIBILITY TO WIN. This Sweepstakes is open to legally operated dealerships in the forty-eight (48) contiguous United States and the District of Columbia (the "Territory"). By participating in the Sweepstakes, entrants (i) agree to be bound by these Official Rules, including all eligibility requirements, and (ii) agree to be bound by the decisions of Sponsor, which are final and binding in all matters. Entries that are incomplete or corrupted are void and will not be eligible. Entries that are not "successfully activated" (defined above) will not be eligible. Sponsor and its agents reserve the right to verify eligibility qualifications of any chosen winner. Failure to comply with these Official

Rules may result in disqualification from the Sweepstakes. This Sweepstakes is subject to all applicable federal, state and local laws and regulations. Void where prohibited by law.

Who is not eligible to win? Employees of Sponsor, or its subsidiaries, affiliates, advertising and promotion agencies, retailers or distributors, and members of their immediate family (e.g., spouses, parents, domestic partners, children, siblings), are not eligible to win.

SPECIAL PUBLICITY NOTICE. Grand Prize consists of: (a) Large Big Green Egg BBQ set, which includes: one (1) Large Big Green Egg BBQ, one (1) BBQ cover, one (1) BBQ stand, two (2) table attachments, one (1) 10lb bag of charcoal (all from Big Green Egg, LLC) (Approximate Retail Value ("ARV") \$1,340); (b) one (1) Yeti Tundra Hard Cooler (ARV \$349.99); (c) four (4) Yeti Rambler mugs (ARV \$99.96); (d) one (1) \$300 Omaha Steak International, Inc gift card (ARV \$300); (e) one (1) Amazon Echo Plus (ARV \$99.99); and (f) a one (1) year of SiriusXM Essential Streaming package (ARV \$156). If potential winning Dealership is unable to receive the Grand Prize, it will forfeit the prize and another winner will be selected from among eligible Entries received. No prize substitution, cash substitution, or assignment or transfer of prizes is permitted, except by Sponsor who may substitute a prize, in whole or part, of equal or greater value. In no event shall more than the number of stated prizes be awarded. All prizes are intended to be awarded. Dealership winner will receive an IRS Form 1099 for the actual value of prize awarded. Sponsor will not replace any lost, damaged, or stolen prize items.

WINNER SELECTION. The potential winning Dealership will be determined by a random drawing following the close of the Entry Period from among all eligible entries received.

ODDS. Odds of winning depend upon the number of eligible Entries received during the Entry Period. This Sweepstakes is intended to be advertised to a maximum of 1,239 franchise and 21,931 independent dealers not yet enrolled in either of the Pre-Owned or Service Lane Programs, a maximum 41,197 dealers already enrolled in the Pre-Owned Program only, 2,888 dealers not yet enrolled in the Service Lane program, and 38,309 dealers already active in both the Pre-Owned and Service Lane Programs (the Participating Dealer Entry Pool). Odds of winning approximately 1:105,564.

WINNER AGREEMENTS. Dealership winner will be notified by telephone and email. Except where prohibited, acceptance of Grand Prize constitutes Dealership winner's consent, and Dealership winner will be required to sign a release, to allow Sponsor and its promotional agents to use Dealership winner's name and likeness, photo, video footage, and/or biographical data, for advertising and promotional purposes, without additional compensation, in perpetuity, in all media, now known or

hereafter developed, in connection with Sponsor, this Sweepstakes, and the Sponsor's web sites. The Grand Prize will be awarded within 30 days after receipt and verification of completed prize notification and Affidavit.
