

2019 MLB® All Star Week™ Getaway Sweepstakes Presented by SiriusXM

OFFICIAL RULES

NO PURCHASE NECESSARY To Enter or Win.

A purchase will not increase your chances of winning.

Void where prohibited. U.S. Law Governs.

Open only to automotive dealerships within the 48 contiguous United States, and DC.

How To Enter. Automotive dealerships which want to enroll in either the Pre-Owned Program and/or Service Lane Program (the “**Programs**” and both groups referred to herein as the “**New Dealer Enrollment Entry Pool**”) can ENTER into the sweepstakes by going to www.siriusxmdealerprograms.com/allstar19, enrolling in either or both of the Programs from 12:01 am ET on **May 20, 2019**, until 5:59 pm ET on **June 21, 2019** (the “**Entry Period**”), and becoming “Successfully Activated.” “**Successfully Activated**” means a dealership was accepted into a Program and Sponsor sent the dealership an activation acknowledgement by **June 28, 2019**. A Program enrollment will also be accepted by faxing your enrollment form as instructed on the form. Proof of fax will not be deemed to be proof of receipt. Each Program enrollment will earn you one sweepstakes entry during the Entry Period (i.e., maximum of 2 sweepstakes entries per dealership is possible). Multiple attempted enrollments in any single Program on behalf of any dealership location will be managed as follows: the first enrollment submitted which causes the dealership to be Successfully Activated in a Program will be deemed the only enrollment valid for sweepstakes entry.

Automotive dealerships currently active and participating in the Programs (referred to herein as the “**Participating Dealer Entry Pool**”) will automatically be entered into this sweepstakes with one (1) entry per Program into which such participating dealer is active and participating (i.e. maximum of two (2) sweepstakes entries is possible for any dealer already in the Participating Dealer Entry Pool). If one of these dealerships is chosen as the potential winner, it may choose to decline the Prize.

Advice to Both Groups: The “**Entrant**” is deemed the dealership. A winner can only be the dealership. Sponsor will notify the Owner, Principal, or General Manager of winner status. If the individual who enrolled the dealership into the Program was not authorized to do so, or if the Owner, Principal or General Manager chooses to decline the Prize, the Prize will be forfeited and Sponsor may select an alternate winner in accordance with the “Winner Selection” process described below. **IF THE DEALERSHIP ACCEPTS THE PRIZE, THE DEALERSHIP MUST DETERMINE WHO WILL GET THE BENEFIT OF THE PRIZE, AND WHO WILL PAY THE TAXES ON THE PRIZE.** The dealership must make the appointment of who will enjoy the benefit of the Prize and who will pay the taxes on the Prize within two (2) business days of being notified of the Prize award, or the Prize will be forfeited and Sponsor will go on to the next randomly selected alternate.

CONDITIONS OF ENTRY / ELIGIBILITY TO WIN. Entrants agree to abide by the terms of these Official Rules and by the decisions of Sponsor which are final. This sweepstakes is open to legal residents of the 48 contiguous United States and the District of Columbia who, at the time of entry, are at least twenty-one (21) years of age and have the authority to act on behalf of and bind the eligible dealership for which it is entering, except wherever prohibited or restricted by law. **THE ENTRANT IS THE AUTOMOTIVE DEALERSHIP, BUT ANY**

EMPLOYEE WHO IS A LEGAL RESIDENT AND OF AGE, MAY BIND THE DEALERSHIP.

This sweepstakes is intended for play in the aforementioned areas only and shall only be construed and evaluated according to United States law. Do not enter this sweepstakes if you are not located in these areas. By participating in the sweepstakes, each Entrant (i) agrees to be bound by these Official Rules, including all eligibility requirements, (ii) agree to be bound by the decisions of Sponsor, which are final and binding in all matters, and (iii) agree that if determined the Prize winner and if Entrant has won any Prize valued at over \$500 from Sponsor within the last six (6) months, Entrant will forfeit winner status and Sponsor may award the Prize to an alternate winner. Dealerships that are enrolled in a Program but not Successfully Activated as set forth above will not be eligible. Any effort by an entrant to misrepresent himself or herself through the use of aliases or multiple e-mail addresses will disqualify all entries of such individual. Sponsor and its agents reserve the right to verify eligibility qualifications of any winner. Failure to comply with these Official Rules may result in disqualification from the sweepstakes. This sweepstakes is subject to all applicable federal, state and local laws and regulations. Void where prohibited by law.

Who is not eligible to enter? Anyone who is not an employee of an automotive dealership is not eligible to enroll a dealership in the Program and therefore is not eligible to enter this sweepstakes. Employees of the Sponsor, "**MLB Entities**" (defined, collectively, as Major League Baseball Properties, Inc., MLB Advanced Media, L.P., The MLB Network, LLC, the Office of the Commissioner of Baseball ("**BOC**"), its Bureaus, Committees, Subcommittees and Councils, the Major League Baseball Clubs ("**Clubs**"), each of their parent, subsidiary, affiliated and related entities, any entity which, now or in the future, controls, is controlled by, or is under common control with the Clubs or the BOC, and the owners, general and limited partners, shareholders, employees, directors, officers and agents of the foregoing entities) and members of their immediate family (e.g., spouses, domestic partners, parents, children, siblings) are not eligible to win.

SPECIAL PUBLICITY NOTICE. By entering this sweepstakes, if you are selected as a winner, you grant to Sponsor, its promotional agents and the MLB Entities your express permission (except where prohibited by law) to use your name, identity, description of Prize won, dealership name, entrant's hometown and likeness, if applicable, for promotional purposes, in any media now known or hereafter developed, including on the radio, and including for "live notification" of potential winner status purposes, without further compensation or notice. PRIZE. One (1) "**Prize**" will be awarded. Prize consists of: (a) round-trip coach air transportation for the winner and his/her one guest, travelling on the same itinerary, to Cleveland Ohio (the "**Destination**") from a major commercial airport in the continental United States nearest to winner's primary residence, as determined by Sponsor; provided, however, that Sponsor reserves the right to substitute ground transportation for air transportation if winner resides within one hundred fifty (150) miles of the Destination; (b) three (3) nights hotel stay in or near the Destination city for winner and guest (one (1) standard double occupancy room); (c) two (2) tickets for winner and guest for the SiriusXM *All-Star Futures Game* scheduled to be played on July 7, 2019, two (2) tickets for winner and guest for the T-Mobile *Home Run Derby* scheduled for on July 8, 2019, and two (2) tickets for winner and guest for the *MLB All-Star Game* presented by Mastercard scheduled to be played on July 9, 2019 (each referred to as an "**Event**"). (Approximate Retail Value ("**ARV**") of Prize package: \$2,500; actual value may vary depending on, among other variables, the Destination, winner and guest's city of departure and fares at time of departure; any difference in value will not be awarded.) **The Prize does not include tickets to any game, event or exhibition during the 2019 MLB All-Star Week™ other than as specifically set forth herein.**

Major League Baseball game, event and exhibition dates and times are determined in the sole discretion of the Office of the Commissioner of Baseball and/or the applicable Major League Baseball Club, as applicable, and may be subject to change.

The terms and conditions of the Event tickets awarded as part of the Prize will govern in the event a legal game, exhibition or event, as defined by Major League Baseball, is not played or held, as applicable, due to weather conditions, an act of God, an act of terrorism, civil disturbance or any other reason. Prize winner and his/her guest(s) agree to comply with all applicable stadium and venue, as applicable, regulations in connection with the Prize. Sponsor and the applicable MLB Entities reserve the right to remove or to deny entry to winner and/or guest who engages in a non-sportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person at the Event. Sponsor and the MLB Entities will not be responsible for weather conditions, Acts of God, acts of terrorism, civil disturbances, work stoppage or any other natural disaster outside their control that may cause the cancellation or postponement of the Event. The Prize (and any portion thereof) is nontransferable. Major League Baseball game, event and exhibition tickets awarded as Prizes may not be resold or offered for resale or used for any commercial or promotional purpose whatsoever. Any such resale or commercial or promotional use may result in disqualification and Prize forfeiture, and may invalidate the license granted by the Event ticket(s). WINNER SELECTION. Winning dealership will be determined by a random drawing, under the supervision of a panel of judges from Sponsor whose decisions are final and binding, following the close of the Entry Period from among all eligible entries received, which dealerships have been determined to have been Successfully Activated (defined above). Subject to verification of eligibility and compliance with these Official Rules, the potential winning dealership will be declared the official winner of the sweepstakes.

Odds. Odds of winning depend upon the number of eligible entries received during the Entry Period. This sweepstakes is being advertised to a maximum of 1,509 franchise and 16,908 independent dealers not yet enrolled in either of the Pre-Owned & Service Lane Programs and a maximum 43,949 dealers already enrolled in the Pre-Owned Program only. Plus to 3,021 dealers not yet enrolled in the Service Lane program (the **New Dealer Enrollment Entry Pool**) as well as 17,243 dealers already active in both the Pre-Owned and Service Lane Programs (the **Participating Dealer Entry Pool**). Odds of winning approximately 1:82,630. This sweepstakes is intended to be advertised as follows: (1) on the Internet at www.siriusxmdealerprograms.com/allstar19, (2) through Dealer Bulletins sent from participating OEM Corporate Headquarters to all their automotive business establishments nationwide, (3) through promotional flyers distributed by SiriusXM Field representatives at Dealerships and (4) through Direct Mail postcards sent to Dealerships.

WINNER AGREEMENTS. Potential winner will be notified by telephone and must then give a valid email address where notification of potential winner status and required documents can be sent.
